Program Overview

- Undergraduate Scholarship to Study or Intern Abroad
- Federal Pell Grant recipients
- Scholarships up to \$5,000
- Up to an additional \$3,000 for critical need languages
 Minimum three weeks (21 days) OR two weeks (14 days) if at two-year institution
- In a country with an overall Travel Advisory level 1 or 2
- Credit-bearing program
- Gilman-McCain Scholarship

 - Recipient of any type of Title IV federal financial aid
 Dependent child of an active duty military member (Air Force, Army, Marine Corps, Navy, and Coast Guard)

- The Fulbright U.S. Student Program awards more than 2,100 grants annually
- Opportunities to study, conduct research, and serve as assistant English teachers in 140 countries around the world, for 8-10 months
- Award for graduating seniors, recent graduates, graduate students and early career professionals
- U.S. Citizen by the application deadline
- Bachelor's degree of equivalent by start of grant
- No terminal doctorate at the time of application
- Fulbrighters represent the richness and diversity of America through their varied backgrounds, home communities, professional and academic skills, and academic
- institutions






